Tooth Talk

As I write this at the end of 2020, I am sure all of you are looking forward to a fresh start in 2021 and hoping for a better year. As you know 2020 had a lot of surprises in it, most of them not very pleasant and some of them down right painful. I know all of you are already aware of both the personal and professional changes that resulted from the Covid virus, so I am just going to focus on an update of how the AGD/ WiAGD has been affected.

I hope all of you are aware of all the CE and Covid updates available through the AGD and have taken advantage of them. I think our professional organizations really rose to the challenge the virus was causing for their members.

The AGD House of Delegate Meeting is normally held in Chicago in Oct. This created a challenge for the staff to create a zoom type meeting for the delegates that allowed Robert's Rules of Order to be followed and would allow all delegates to be involved in discussions and voting. While there were some technical issues, and some frustration on the part of the delegates, overall the AGD staff deserve a pat on the back for getting this set up. Thank you to our delegates, Drs. Lou Boryc, Ed Batchelor, Ginny Scott, John Machi and Van Anh Le for attending. As a personal note, while this did work, I really missed the chance to talk and interact with other delegates and get their input and hope that by next Oct. we will be back to normal. Please refer to the AGD website for an update on the agenda and the results of the national election.

During the House of Delegates Meeting, our Region 9 elected new officers. Dr. Dennis Charnesky will now be our Regional Trustee and Dr. Lou Boryc will be our Regional Director. Thanks to both of these members for their dedication and support of the AGD.

During 2020 our President Dr. Boryc took on the challenge of updating our website. He has spent a lot of time researching several different options and we are hopeful that in 2021 we will have a new, easier to use, updated website for the WiAGD.

While the virus has put many things on hold or slowed them down, the efforts to pass a bill creating dental Midlevel Providers was not one of them. Dr. Chris Hansen has been very active at the legislative level on this issue, please read his article for more information on this. Since it appears that it is inevitable that a bill creating midlevel providers will be passed, we are hoping to at least minimize the damage this bill will create. Our President, Dr. Boryc became aware of a legislative grant available through the AGD for the support of a lobbyist at our state level. The WiAGD Board made a decision to hire a lobbyist on our behalf to address the issue of the Midlevel Providers. For the protection of our patients we hope we can influence the important issues of type and length of education requirements, the scope of their practice guidelines, and their supervision requirements. We feel that these important restrictions and regulations should be made with the input of general dentists. We are aware of the efforts of the WDA on this issue, but feel that the backing of our organization may influence or provide addition support for our concerns.

The other area affected by the Covid virus was our CE curriculum. Right off the bat, our March CE with Dr. Landswehr had to be cancelled. We thought we were safe in Oct, but only found out a couple of weeks before the date that the hotel was cancelling. Both of these events have been rescheduled for 2021, but at this time we are still not sure if we can do them live or possibly virtual. We have decided to list the dates and speakers so you can mark your calendars, but no definite plans will be announced at this time. Once the CE committee makes a decision we will e-blast the information out to all members on our list and will post the information on the website, www.WiAGD.org. The WiAGD continues to strongly support our goal of providing CE for our members. Wisconsin AGD Legislative Update

After a tumultuous campaign season of 2020, the Wisconsin legislature is set to begin the new session on January 14, 2021. Of concern to most Wisconsin AGD dentists are workforce issues revolving around the education and licensing of Midlevel Providers (MLP). Bills presented in the 2019-20 session in both the Assembly and Senate promoting Dental Therapy were stalled in committee and never came to a floor vote. Final passage of this legislation was blocked as result of lobbying efforts by the WDA in partnership with Marquette School of Dentistry and the Wisconsin AGD.

Our direct opposition on this issue for the last several sessions has come at a significant cost in political capital. By focusing on Dental Therapy (DT), we have lost the political initiative in other issues important to the profession. These include improving Medical Assistance (MA) reimbursement for dental services, expanding the Dental MA Pilot program, allowing training and licensing of Expanded Duty Dental Assistants (EFDA) and regulating some unfair practices by third party payors.

Currently, 12 states have legislation that allow MLPs in some version. In 2020, there was no new MLP legislation passed in the United States. This is in large part because of COVID and shortened legislative sessions nationwide. Nearly all mid-level provider practitioners are in Minnesota. Maine just got its first practicing dental therapist, years after passing their DT legislation.

Make no mistake, the Dental Therapy bill presented in 2019 authored by then Rep. Mary Felzkowski of Tomahawk is unacceptable as written. But the bill and this issue is not going away, and its primary author was recently elected to the State Senate and has been assigned to the very influential Joint Finance Committee. It is expected that this will be one of the first pieces of legislation that will be introduced after the new year.

The concept of Dental Therapy has the support of a coalition of over 50 influential stakeholders and has bipartisan support in the legislature. It is expected that our opposition wall will collapse under the pressure of this bill, meaning it will likely pass with or without organized dentistry's input. If dentistry's voice is not heard, the void will be filled with others with views that may not be in the best interest of dentistry or the oral health of our patients.

We need to be at the table to make a potential Dental Therapy bill better or without our input we risk that the broadest, most unregulated dental therapy bill in the nation may pass. Based on what happened in the last legislative session this was very close to becoming a reality. We need to incorporate common-sense provisions that other states have included to protect dentistry and at the same time craft the best possible bill for the people of Wisconsin.

Organized dentistry has not only suffered legislatively, but without being able to sponsor any meaningful reform or legislation in the last several years, our brand has been tarnished in the eyes of the Wisconsin state lawmakers. If we focus too much on the Dental Therapy issue, we run the risk of being unable to address important access and third-party payor policy issues for the foreseeable future. The focus needs to be on improving access to care to our most vulnerable patients and we cannot be seen as obstructing that aim.
